### THE PASSING OF FRIEND AND COLLEAGUE WILLIAM B. WAGONER

Cedar Point grieves as we announce the passing of former Chairman William “Bill” Wagoner. Mr. Wagoner was a faithful member of the Board of Directors at the credit union for over 50 years. He served in various capacities including on the Credit Committee and Supervisory Committee, and he was Chairman of the board for over a decade. Mr. Wagoner celebrated his 50th anniversary with Cedar Point in 2020.

Throughout his years of service to Cedar Point, he oversaw big changes for the growing credit union. His leadership was vital to the success of projects like the building of new branch offices and ATMs and the change in the credit union’s Charter that allowed it to open to the community in 2009. Mr. Wagoner also supported the credit union movement by participating in lobbying efforts on Capitol Hill.

Employees and board members remember his generous laugh and infectious smile, and his commitment to the credit union mission. “He always sat down with me to talk about credit union business even when it wasn’t time for a board meeting,” remembers Linda Knott, Executive Vice President. “He was dedicated to the business.”

CEO Charles Roach remembers Mr. Wagoner’s commitment to the credit union. “He was a volunteer for so many years, and his participation on the Board was as important to him as any job.” Roach remembers many meetings with Mr. Wagoner in which he professed his belief in the credit union mission. “People helping people was the credit union industry mantra for years, and Bill Wagoner embodied that,” said Roach.

Mr. Wagoner formed lifelong bonds on the Board at Cedar Point with Gene Townsend, Perry Rothwell, Robert Clements, Anne Marum, and other board members and employees. He made a point of visiting departments and lobbies to check in with employees. He even donated office supplies to Cedar Point early in his tenure at the credit union. Mr. Wagoner’s dedication to the credit union lasted through the end of his life; he was a board member until his passing on Thursday, February 23, 2023.

## JOB SHADOW DAY

On February 16th, the students from the Chopticon High School Academy of Finance stepped out of their daily classroom routine to spend a day in the real world. As they have for a number of years 8 students spent the day visiting the Headquarters Office of Cedar Point Federal Credit Union in Lexington Park, Maryland. The students completed a tour of the credit union and then met with representatives from various departments. They learned about the many different aspects of keeping a financial institution running smoothly from what training a teller receives to the importance of continuously updating the marketing strategies and technology used by a financial institution.



Cindy Baden, who is The Academy of Finance teacher, accompanied the students during the tour and learning experience. "This is a great way for our students to be introduced to what it takes to make a financial institution run smoothly behind the scenes. The presentations allowed them to increase their knowledge of the skills needed for specific jobs and educated them on the types of jobs available to someone who is interested in business, accounting, and finance. Many had accounts at a financial institution but had no idea the many job opportunities available."

Cedar Point staff and management, along with the teachers and students, praised the event as a way to underscore the importance of a good education as a basis for future success. Cedar Point believes strongly that the Job Shadow experience shows students the many opportunities available within the local community and allows them to see firsthand how the lessons taught in the classroom apply to the working world. 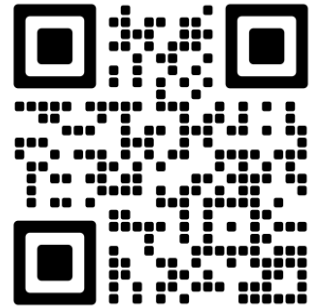
