# PREVENT IDENTITY THEFT WHEN TRAVELING

As you make your travel plans, plan how you'll keep your personal information safe. When you're away from home, distractions become opportunities for thieves who are looking for ways to steal your identity. Don't let them ruin your vacation.

These simple steps can save you hours of frustration and hundreds of dollars or more.

# Before you go:

- Have your mail collected or held at the post office.
- Don't blog, tweet, or post your travel plans on social networking sites.
- Decide which credit cards you'll take (as few as possible) and how you'll hide a backup in case one is lost, stolen, or canceled.
- Make a list of everything you plan to carry in your wallet.
- Make a list of important phone numbers, including the numbers of Cedar Point Federal Credit Union and other credit card issuers.
- At home, make sure your financial documents aren't sitting in plain view.
- Contact Cedar Point and let us know your plans so we can flag your account.

### When out and about:

- Don't carry extra credit cards or personal information, such as your Social Security number, in your wallet or purse unless necessary.
- Never leave your purse or wallet unattended.
- Beware of distractions. Criminals create or take advantage of distractions and then try to steal your personal items.
- Assume public wireless establishments aren't secure—don't enter passwords or financial account information when using a public wireless "hot spot" or cyber café.
- Use cash when possible.
- Confirm credit card numbers in person at hotels instead of over the phone.

# When accessing your accounts or paying bills online:

- Use a secure network, such as your hotel business center, with up-to-date antivirus software and a firewall.
- Don't access your personal information from a public computer.
- Fully log out of your account when finished.

### When using an ATM:

- Try not to use an ATM that's outside. Try to use ATMs that are indoors, such as inside a financial institution.
- Be aware of your surroundings when entering your PIN and receiving cash.

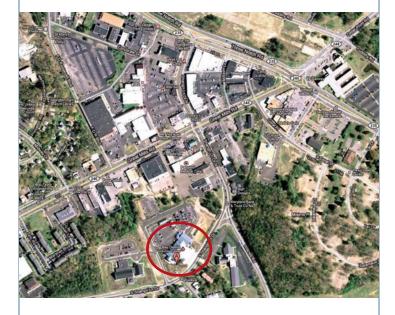
